If you enter the same dog in more than one class in one trial, the highest priced class is considered the first entry, so if you enter the same dog in two regular classes, your fee would be \$48.00. The Obedience Trial and Rally trial are two separate trials. If you enter the same dog in one regular class in obedience and one class in rally, your fee would be \$28 per trial for \$56.00

- ❖ Entries must be submitted by mail on official AKC entry form or through Showentries.info. <https://showentries.info>. Payment for on-line entries will be received through Stripe.
- ❖ Entries must be complete, with proper payment of entry fees to be considered a valid entry.
- ❖ **An e-mail notification will be sent when your entries are received; after entries close, official confirmations, including armband numbers, judging program, etc. will be sent via e-mail. Please configure your e-mail software to allow receipt of information from shawfrances@bellsouth.net. If you wish to receive conformation via US Postal Service please include a stamped self-addressed envelope with your entry.**
- ❖ A refund of entry fees for bitches that come in season after closing date of the show may be obtained by providing a veterinarian's certificate to the Trial Secretary before the start of the show.
- ❖ Changes, additions or corrections to entries must be received in writing or by email prior to close of entries. Refunds may be charged a service fee.
- ❖ There will be no refund for duplicate entries.
- ❖ RETURNED CHECKS do not constitute a valid entry fee. The Trial Secretary will add a \$30.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

LIMITED ENTRIES (8 hours per judge)

Entries will be limited in accordance with Chapter 1, Section 27 of the AKC Regulations. Each judge will be limited to a total of eight hours of judging time per day. Entries will be processed in the order received and time limits calculated for each judge until the 8-hour per day judging limit is reached or entries close. Rally RAE and RACH Class entries will be given priority.

TRANSFERS BETWEEN CLASSES

Transfers between classes within the same trial will be allowed. The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. Transfers may be approved provided the class and judge are available, and the class has not reached its limit. Transfers between an "A" and "B" class at the same level are allowed.

Go 9.3 miles to Seven Springs Road (just past Hinds Blvd & Eagle Ridge Golf Course).

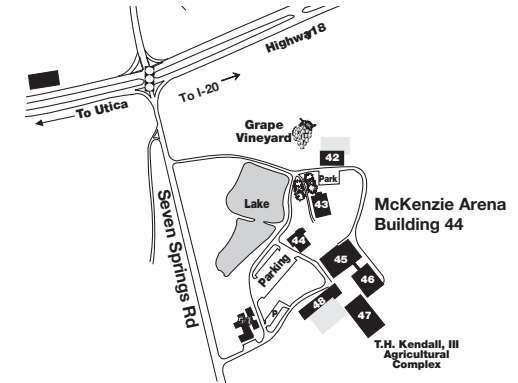
At the stop light, turn left onto Seven Springs Road.

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e. A or B division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Dogs listed in the **AKC Canine PartnersSM Program** may be eligible to enter all-breed AKC Obedience trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

AGREEMENT
