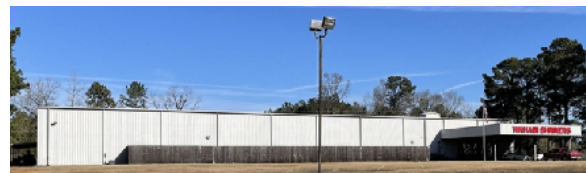

## LIMITED ENTRIES

Entries will be limited in accordance with Chapter 1, Section 27 of the AKC Regulations. Each judge will be limited to a total of eight hours of judging time per day. Obedience Open and Utility (A & B classes) entries will be limited to 25 dogs each. Entries will be processed in the order received and time limits calculated for each judge until the 8-hour per day judging limit is reached or entries close. Obedience UDX Class and Rally RAE and RACH Classes entries will be given priority.

## TRANSFER BETWEEN CLASSES

Transfers between classes within the same trial will be allowed. The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial. Transfers may be approved provided the class and judge are available, and the class has not reached its limit. Transfers between an "A" and "B" class at the same level are allowed.

## ENTRIES

- Entries must be submitted by mail on official AKC entry form or thru Showentries.info. <https://showentries.info>
- Entries must be complete, including signature, jump height, and proper payment of entry fees to be considered a valid entry.
- **An e-mail notification will be sent when your entries are received. Official confirmations, including armband numbers, judging program, etc. will be sent via e-mail.** Please configure your e-mail software to allow receipt of information from shawfrances@bellsouth.net. **Be sure to check your junk mail folder.** If you wish to receive confirmation via US Postal Service, please include a stamped self-addressed envelope with your entry.
- A Refund of entry fees will be made for bitches that come in season after the closing date of the show. Refunds may be obtained by sending a veterinarian's certificate to the Trial Secretary. This certificate must be postmarked before the opening day of the show or given to the Trial Secretary before the start of the show.
- Changes, additions or corrections of entries must be received in writing or by email prior to close of entries.
- There will be no refund for duplicate entries.
- Refunds for cancelations made in writing before the close of entries may be charged a \$25.00 fee. No refunds will be made after the close of entries except as allowed by AKC regulations.
- RETURNED CHECKS do not constitute a valid entry fee. The Trial Secretary will add a \$30.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a CASH ONLY basis.

## ATTENTION EXHIBITORS

- ◆ The Show Site will be available to exhibitors from 12:00 pm Friday and 7:00 am Saturday and Sunday. Dogs must be removed from the show site immediately after close of activities each day.
- ◆ Please bring waterproof covering to put under your crates.
- ◆ No dogs will be allowed in the restrooms.
- ◆ Dumping of dog food into the restroom sinks or toilets is strictly prohibited.
- ◆ Exhibitors are responsible for picking up after their dogs on the show site. Do not allow your dog to urinate/mark inside the building or on the front of the building.
- ◆ Per Sections 1 & 2 of AKC's Dealing with Misconduct, the Show Committee reserves the right to retain Show Committee jurisdiction over exhibitors whose names have been referred by hotels/motels as having left their rooms and/or grounds in a state that appears negligent or offensive. The exhibitor will be responsible for picking up after their dogs at the motels/hotels.
- ◆ The Jackson Obedience Training Club assumes no responsibility for any loss, damage or injury sustained by exhibitors or to any of their dogs or property & further assume no responsibility for injury to children. Any & all damages caused by exhibitor, exhibitor's dogs or children will be the sole responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control & restraint over their children during the trials.
- ◆ **WAIVER OF RIGHTS** The Jackson Obedience Training Club reserves the right to remove any animal in distress from a parked vehicle or crate, and all persons attending the JOTC trials hereby waive any claim for damages against the clubs for such removal.
- ◆ Jackson Obedience Training Club, Inc. reserves the right to substitute a prize of equal or greater value.
- ◆ Dogs must be ready for judging. Neither the club nor its Trial Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agents of class judging. Judges need not wait for any dog holding up a class.
- ◆ Entry Fees will not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or judge or barred from competition by action of the Show Committee.
- ◆ No entry fees will be refunded if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the Club or the Trial Secretary.

## INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, A or B division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. State on entry form whether transfer application has been mailed to the AKC. (For complete rules, refer to Chapter 11, Section 3.)
- Dogs listed in the **AKC Canine PartnersSM Program** may be eligible to enter all-breed AKC Obedience trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.
